**Wadim Strielkowski**, PhD, is a Professor at Prague Business School (Czech Republic), Research Fellow at the Czech University of Life Sciences Prague, Senior Researcher at the Cambridge Institute for Advanced Studies, a Managing Director of Prague Institute for Qualification Enhancement, and a Visiting Professor at the University of California, Berkeley. His previous roles included Research Associate at the Cambridge Judge Business School, University of Cambridge (2016-2017), Assistant Professor of Economics at the Charles University in Prague (2008-2015), and Research Fellow at the University of Nottingham (2006-2009). He is a top reviewer in Cross-Field (top 1% in field) according to Web of Science and Publons. Dr Strielkowski is an editor of books and proceedings on leadership in business and economics published by Springer Nature and Atlantis Press. Dr Strielkowski is a prolific author publishing in world's top scientific journals. He is an author

or co-author of over 230 articles in peer-reviewed journals. He works as an expert for the European Commission and consultancies in several European Union countries, China, United States, and Russian Federation.
